Section 93.318 requires an institution to immediately notify ORI if at any time during the research misconduct proceeding the institution has reason to believe that any of the following conditions exist: (1) The health or safety of the public is at risk, including an immediate need to protect human or animal subjects; (2) HHS resources or interests are threatened; (3) Research activities should be suspended; (4) There is a reasonable indication of possible violations of civil or criminal law ...
